These redactions obstruct my right to access and preserve evidence of my own complaint. 2.There were no police involved in this matter, contrary to what may have been suggested or implied in redacted material. 3.The individual who entered my apartment is a public servant operating under HUD funding. He refused to identify himself during an in-person inspection and concealed his badge. I asked for his name, and HUD has redacted it on false grounds. There is no legitimate privacy interest under Exemption (b)(6) or (b)(7)(C) in protecting the identity of a government inspector performing official duties on federal property—particularly when they have engaged in misconduct and failed to follow HUD's own inspection procedures. 4.Exemption (b)(7)(E), which protects law enforcement techniques, is also improperly applied.
